1. SCOPE OF COVER

The Insured person is covered if diagnosed with COVID-19 during the insured trip or within thirty (30) days prior to the scheduled trip departure date, provided travel insurance is taken prior to such diagnosis.

2. ELIGIBILITY

Travelers with ages fifteen (15) to fifty-nine (59), may avail Travel Protect Insurance with COVID-19 cover.

- for Outbound trips maximum of ninety (90) days only
- for Inbound trips maximum of thirty (30) days only

The package is intended for persons traveling on vacation, study or seminars/conferences. This package excludes cover for skilled persons / skilled laborers when traveling for the purpose of employment or in the course of employment. Also, COVID-19 high risk occupations such as healthcare workers, nursing professions are excluded.

3. DESTINATION

COVID-19 coverage is limited to the following countries / destinations only:

- All ASIAN Countries, except Indonesia
- Japan
- Australia
- New Zealand
- United States

4. SPECIFIC EXCLUSIONS

- a. Trip cancellation or termination solely due to epidemic-related / pandemic-related travel advisories issued by governments, health authorities or the World Health Organization, by or for destination country or origin country.
- b. Trip cancellation or termination resulting solely from border closures, quarantine or other government orders, advisories, regulations or directives.
- c. Trip cancellation or termination, if trip is cancelled or terminated because of disinclination to travel, change of mind or fear of traveling.
- d. Trip cancellation or termination, if the hotel, travel agent or any other provider of travel and/or accommodation has offered a voucher or credit or re-booking of the trip for cancellation refund or compensation.
- e. Traveling against a medical practitioner's or doctor's advice, or any claim arising from the insured person acting in a way that goes against the advice of a medical practitioner or doctor.
